APPLIED LOGIC FOR COMPUTER SCIENCE, Fall 2021****1. Course Information****Course Information**

The course is an introduction to logic for computer science. We will cover propositional and predicate logic; representing static and dynamic properties of real-world systems; logic as a tool for representation, reasoning and calculation; logic and programming.

**List of Prerequisites**

Either 1) Computer Science 1027A/B, Computer Science 1037A/B, Computer Science 2101A/B, Computer Science 2121A/B or Digital Humanities 2221A/B in each case with at least 65%, and 1.0 course with at least 60% in each from: Applied Mathematics 1201A/B, Numerical and Mathematical Methods 1412A/B, Numerical and Mathematical Methods 1414A/B, Calculus 1000A/B, Calculus 1301A/B, Calculus 1500A/B, Calculus 1501A/B, Mathematics 1600A/B, the former Applied Mathematics 1412A/B, the former Applied Mathematics 1414A/B, the former Applied Mathematics 1413; or 2) Integrated Science 1001X with at least 60%.

Unless you have either the requisites for this course or written special permission from your Dean to enroll in it, you may be removed from this course and it will be deleted from your record. This decision may not be appealed. You will receive no adjustment to your fees in the event that you are dropped from a course for failing to have the necessary prerequisites.

## 5. Methods of Evaluation

- Five assignments: the first one is 5%, and then 10% for the remaining four

### **Accommodated Evaluations**

*Generally, no extensions to assignments will be given (except for lengthy illness, or other compassionate grounds). In those cases where an extension is granted, the course instructor can grant the extension. If you have serious medical or compassionate grounds for an extension, you should take supporting documentation to the office of the Dean of your faculty, who will contact the instructor.*

*There will be no makeup Midterm Exam, except for students requesting a Special Midterm Exam for religious reasons. These students must have notified the course instructor and filed documentation with their Dean's office at least 2 weeks prior to the Midterm Exam in question.*

*If you miss the Midterm Exam for any other reason, and present valid documentation to the Dean's office, your Final Exam mark will be reweighted to include the weight of the Midterm Exam. You must notify the course instructor within a week of the missed Midterm Exam, and documentation must be received by your Dean's office within 2 weeks of the missed exam.*

*If for any reason the assignment schedule given below cannot be adhered to, the assignment marks will be prorated. (The  $n$  assignments are worth  $k\%$  of the overall mark for the course. If an assignment has to be cancelled for any reason, the remaining assignment weights will be prorated to add up to  $k\%$ .)*

*Every effort will be made to have assignments marked and handed back within 3 weeks of the handin date, preferably sooner.*

## **6. Student Absences**

### **Academic Consideration for Student Absences**

Students who experience an extenuating circumstance (illness, injury or other extenuating circumstance) sufficiently significant to temporarily render them unable to meet academic requirements may submit a request for academic consideration through the following routes:

- (i) Submitting a Self-Reported Absence (SRA) form provided that the conditions for submission are met. To be eligible for a Self-Reported Absence:

- an absence must be no more than 48 hours
  - the assessments must be worth no more than 30% of the student's final grade
  - no more than two SRAs may be submitted during the Fall/Winter term
- (ii) For medical absences, submitting a Student Medical Certificate (SMC) signed by a licensed medical or mental health practitioner to the Academic Counselling office of their Faculty of Registration.
- (iii) Submitting appropriate documentation for non-medical absences to the Academic Counselling office in their Faculty of Registration.

Note that in all cases, students are required to contact their instructors within 24 hours of the end of the period covered, unless otherwise instructed in the course outline.

Students should also note that individual instructors are not permitted to receive documentation directly from a student, whether in support of an application for consideration on medical grounds, or for other reasons. **All documentation required for absences that are not covered by the Self-Reported Absence Policy must be submitted to the Academic Counselling office of a student's Home Faculty.**

If you miss the Final Exam, please contact the Academic Counselling office of your Faculty of Registration as soon as you are able to do so. They will assess your eligibility to write the Special Examination (the name given by the University to a makeup Final Exam).

You may also be eligible to write the Special Exam if you are in a "Multiple Exam Situation" (e.g., more than 2 exams in 23-hour period, more than 3 exams in a 47-hour period).

If a student fails to write a scheduled Special Examination, the date of the next Special Examination (if granted) normally will be the scheduled date for the final exam the next time this course is offered. The maximum course load for that term will be reduced by the credit of the course(s) for which the
